Information about this children's home

This home is one of a number of homes operated by a private provider. The home provides care and accommodation for up to 29 children or young people who have disabilities and/or behavioural needs. Accommodation is provided across nine individual houses on the site.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged requires improvement to be good at the last full inspection. At the interim inspection, Ofsted judges that it has sustained effectiveness.

During this inspection, it was found that although some improvements have been achieved, the home has made minimal progress in meeting requirements. Therefore, the home continues to require improvement in all areas.

Safeguarding practice is improving but is still inconsistent. In some instances, potential safeguarding concerns have not been identified. When safeguarding concerns are identified, staff and managers do not always follow correct procedures, in terms of reporting them to the appropriate agencies.

Young people's risk assessments lack clarity in some areas. In some examples, risks are not clearly identified, and risk assessments are not updated when new information is

available. Guidance for staff about how to manage identified risks is not consistently clear. This means that staff may not have adequate information about how to maintain young people's safety and well-being.

A staff recruitment programme is ongoing, and improvements have been made to the training programme. However, there is a high use of agency staff. Arrangements to ensure that agency staff have the appropriate skills, knowledge and qualifications to support young people are not effective. For example, a pool of agency staff had been put in place to support a young person with highly complex needs. During the inspection, it was confirmed that the majority of these agency staff did not hold the qualifications that managers thought they had.

Systems to monitor quality and safety across the service are not always used in an effective way. For example, records of physical restraints involving young people are often signed off by managers commenting on the quality of the recording, without any scrutiny of the incident itself. Therefore, no meaningful analysis or reflection takes place.

At the last inspection, it was identified that managers do not always respond effectively to serious incidents or near misses. Continuing shortfalls were identified in this area during this inspection. Not all serious incidents are reviewed effectively. As a result, opportunities to reflect and learn from adverse events are not utilised.

When serious incidents are reviewed, the quality of investigation is variable. Investigations are often concluded without a clear outcome or rationale as to how a conclusion has been reached. In some examples, potential learning is identified but not consistently implemented. This means that opportunities to prevent reoccurrence, improve practice and provide young people with safer care are lost.

Not all significant incidents are reported to Ofsted in accordance with regulation. This undermines the regulator's ability to carry out effective monitoring. Consequently, young people's welfare is not fully promoted.

Significant changes have been made to the management structure within the home. Additional managers have been appointed and have specific responsibilities for smaller areas. These new arrangements were due to commence on the day that this inspection took place and therefore the home had not yet benefited from the new management structure. Staff were positive about the new structure and many felt it would lead to more effective leadership across the home.

Recommendations

■ Staff should be familiar with the home's policies on record keeping and understand the importance of careful, objective, and clear recording. Staff should record information on individual children in a non-stigmatising way that distinguishes between fact, opinion and third-party information. Information about the child must always be recorded in a way that will be helpful to the child. ('Guide to the children's homes regulations including the quality standards', page 62, paragraph 14.4)

Information about this inspection

Inspectors have looked closely at the experiences and progress of children and young people. Inspectors considered the quality of work and the differences made to the lives of children and young people. They watched how professional staff work with children and young people and each other and discussed the effectiveness of help and care provided. Wherever possible, they talked to children and young people and their families. In addition, the inspectors have tried to understand what the children's home knows about how well it is performing, how well it is doing and what difference it is making for the children and young people whom it is trying to help, protect and look after.

This inspection focused on the effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection.

Using the 'Social care common inspection framework', this inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the children's homes regulations including the quality standards'.
